SECTION 2- HAZARDS IDENTIFICATION

Statement of Hazardous Nature

This product is classified as: N, Dangerous to the environment. C, Corrosive. Hazardous according to the criteria of SWA.

Not a Dangerous Good according to Australian Dangerous Goods (ADG) Code, IATA or IMDG/IMSBC criteria.

Risk Phrases: R34, R43, R51. Causes burns. May cause sensitisation by skin contact. Toxic to aquatic organisms.

Safety Phrases: S20, S23, S26, S28, S36, S46, S61, S24/25, S37/39. When using, do not eat or drink. Do not breathe vapours. In case of contact with eyes, rinse immediately with plenty of water and contact a doctor or Poisons Information Centre. After contact with skin, wash immediately with plenty of soap and water. Wear suitable protective clothing. If swallowed, contact a doctor or Poisons Information Centre immediately and show this SDS or label. Avoid release to the environment. SECTION 4- FIRST AID MEASURES

Ingestion

If swallowed, do not induce vomiting. Give 250 ml water to rinse out mouth and drink. Seek immediate medical attention.

Immediately flush eyes with large amount of water for at least 15 minutes. Seek immediate medical attention.

Skin contact

SECTION 5- FIRE FIGHTING MEASURES

SECTION 6- ACCIDENTAL RELEASE MEASURES

Accidental Release: This product is sold in small packages and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up,

rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

SECTION 7- HANDLING AND STORAGE

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

Eyebaths or eyewash stations and safety deluge showers should, if practical, be provided near to where this product is being handled commercially.

SECTION 10- STABILITY AND REACTIVITY

Reactivity: This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

Conditions to Avoid: Keep containers tightly closed. Containers should be kept dry.

Incompatibilities: strong acids, oxidising agents.

Fire Decomposition: Combustion forms carbon dioxide, and if incomplete, carbon monoxide and possibly smoke. Water is also formed. May form nitrogen and its compounds, and under some circumstances, oxides of nitrogen. Occasionally hydrogen cyanide gas in reducing atmospheres. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Polymerisation: Polymerisation reactions are unlikely; they are not expected to occur.
